Subject:- Revised Draft Electoral Roll prepared under the provisions of the Indian Veterinary Council (IVC) Rules, 1985 – regarding.

Sir/Madam,

1. This is in reference to the Department of Animal Husbandry, Dairying and Fisheries Ministry of Agriculture, Govt. of India letters No. 52-22/2011-LDT (VC) dated 5.3.2014, dated 6.3.2014 and dated 13.3.2014 wherein it was advised that the Council shall prepare the revised Electoral Roll for the purpose of circulation amongst the State/UT Veterinary Councils for display for obtaining of objections and claims from the Registered Veterinary practitioners (RVP) as provided under IVC Rules.
2. Accordingly, the revised draft Electoral Roll has been prepared containing the names of all registered veterinary practitioners whose names have been entered in the IVPR upto 31.3.2013 and published in Extraordinary Gazette of India including updated addresses as provided by the various State/UT Veterinary Councils. A copy of the revised draft Electoral Roll (year-wise) in respect of your Veterinary Councils is enclosed for inspection by the registered practitioners as provided under rule 5 of the said Rules. A copy of the complete revised draft Electoral Roll in soft copy (CD) is also enclosed herewith for your reference and taking necessary action.
3. It has been decided to display the draft Electoral Roll w.e.f 25.3.2014 to 8.4.2014 i.e. for 15 days as has been provided under rule 6 of the said Rules.
4. In this regard, I am to invite your kind attention to the relevant provisions of rules 6 and 7 of the IVC Rules, 1985 which may be seen at Annexure -1.
5. In order to make the process of finalization of the Electoral Roll uniform across all the State/UT. Veterinary Councils, four (4) Proformas namely, "Form- A" (for inclusion of name of registered veterinary practitioner whose name has been published in IVPR but not included in draft Electoral Roll); "Form-B" (for making objections in the entry in the Roll); "Form-C" (for deletion of name of the Registered Veterinary practitioner on account of death or cancellation of registration due to


transfer of registration from one State to another State Veterinary Council as per Section 52 of the IVC Act, 1984) and "Form-D" (for change of address of the practitioner in the Roll); have been devised and enclosed with this letter. All claims/objections/change of address/deletion of names etc should be invariably submitted in the aforesaid prescribed proformas and duly signed by the Registered Veterinary practitioner (as applicable) and signed/countersigned by the Registrar, State/UT Veterinary Council. It may be noted that no cognizance shall be taken by the undersigned, if the information as mentioned above are not received in the prescribed format and signed by the concerned Practitioner/Registrar.

6. In view of the above, it is requested to kindly arrange to display the revised draft Electoral Roll at the office of State/UT Veterinary Council w.e.f 25.3.2014 to 8.4.2014 for inspection by the registered veterinary practitioners. The last date for receipt of claims/objections/change of address etc from the RVP shall be 8.4.2014 in the prescribed aforesaid formats at the concerned State/UT Veterinary Council. The last date for forwarding of aforesaid claims/objections/change of address etc so received from the RVP by the Registrar of the State/UT Veterinary Council shall be 23.4.2014 (i.e. 15 days) positively. In case no claim/objection/change of address/deletion of names on account of death/transfer etc in the prescribed format as mentioned above is received by this Office by 27.4.2014, it will be presumed that no claim/objection/change of address etc has been made by the practitioners registered with your State/UT Council and the Electoral Roll shall be finalized accordingly. No further correspondence in this regard shall be entertained.

7. The complete revised draft Electoral Roll, Prescribed Forms (A,B,C & D) and the Schedule for Finalization of the Roll have been made available in the Council office as well as displayed on the VCI website namely www.vciresults.com under link "Draft Electoral Roll", "Forms A to D" and "Important Dates for Finalization of the Roll" for information to the Registered Veterinary Practitioners. A Public Notice to this effect is being published in the Newspapers on 25.3.2014 for the kind information of all the concerned. You may also take necessary steps for making wider publicity of the matter for general awareness amongst the registered veterinary practitioners.

8. This may kindly be dealt with due priority to fulfill the statutory requirements as provided under the IVC Act, 1984 and the IVC Rules, 1985.
